## By signing this application form:

- (i) You agree to abide by the HFSC Club Boat Scheme Rules. Your attention is drawn specifically to the following points:
  - a. You agree to use the Club's reservation system and not to use a club boat without a reservation.
  - b. You acknowledge that the club boat is your responsibility on land or at sea from the time that the tie-downs are removed in the Club compound, until the tie-downs are correctly replaced, or the boat is handed-over to (and accepted by) another CBS member.
  - c. You agree to pay for the cost of loss or damage to the club boat or its equipment arising from your use of the boat, and:
    - i. Your liability for loss or damage per incident will initially equal the LDF
    - ii. Your liability for loss or damage will increment by the value of the LDF every time that HFSC incurs any cost in connection with your use of the club boat (whether paid from Club funds or via an insurance claim).
  - d. You agree to report any damage to the Club Boat Officer or his/her designated deputy as soon as possible.
- (ii) You acknowledge that you are responsible for the safety of yourself and your crew whilst using the club boat. By launching (or putting to sea) you imply the suitability of the boat and the competence of the skipper and crew for the expected or forecast conditions. Nothing done by HFSC, its officers or volunteers will relieve you of your responsibilities.
- (iii) You acknowledge that HFSC does not provide a rescue service (safety cover) of any kind for those using club boats. HFSC provides support boat cover for certain Club events and whilst reasonable efforts will be made to provide support to those taking part in Club events this should not be relied upon especially in extreme weather conditions, and in any event the level of assistance is limited to that which can be practically provided in the circumstances.
